COOKIES

- i. A cookie is a small text file that is stored by the browser of your computer, tablet, or smartphone when you first visit our website.

 - Functional cookies: These are cookies with a purely technical functionality. These ensure

 These cookies are placed when using analytical service providers, such as Google
 Analytics.
 - Tracking cookies: These cookies are placed by an external party. By reading these cookies
 the advertiser recognizes you when you visit a site in which he is also involved. If you
 continue browsing, personalized ads can be shown. These cookies can also keep track of
 your online behaviour, which may result in a very specific profile being built by these
 parties. This profile can be so detailed that it is considered personal data.

Placement of cookies, other than functional or anonymous analytical cookies, takes place only after an active action by you as a visitor. You can change your settings at any time via our website.
